CHECK-IN & MEASUREMENTS



All agility dogs are required to have an Official Jump Height Card.

Our Judge, Tim Verrelli is a Measuring Official (VMO). ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. Forms will be available at the ribbon-label table. Please fill out a form before requesting to be measured. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it.

If your dog needs to be measured, it is your responsibility to have it done before you run. Failure to do so will result in removal of any qualifying runs you receive.

ARMBAND STICKERS NOT REQUIRED

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), the club will not be requiring the use of armband stickers, so traditional check-in is not required.

No paper check-in will be required. **We will be using the Agility Gate App for check-in on your phone.... See Page 2 for more information.**

PLEASE BE SURE TO CHECK IN EACH MORNING ON AGILITY GATE.

If you will be absent, please mark that on Agility Gate for each day as well.

DOGS MAY NOT BE LEFT IN THE BUILDING OVERNIGHT.

MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the trial secretary via email **no later than Monday, January 8, 2024 at 6:00 pm.** Day-to-Day Move-Ups are permitted if you fill out a move-up form (available at the ribbon label table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Fri for a Sat move-up, or on Sat. for a Sun. move-up.



ARRIVAL & SETUP-IMPORTANT!

Thursday, January 11: Red Dirt workers are allowed to set up at 12:00 noon; other exhibitors can enter the building at 1:30 pm. **The building WILL NOT be open before 1:30 pm for Exhibitors.**

The building will also be open no later than 6:30 a.m. all three days.

CONCESSIONS

IMPORTANT!

Course maps will be posted per AKC Agility Regulations. **There will be no printed**

copies of course maps for exhibitors.

Exhibitors may take a picture of the posted course maps. **Also, maps will be posted to the Agility Gate App at midnight the night before each trial day.**

A preliminary running order will be posted on the www.ntxaquility.com website on or before Wednesday prior to the first day of the trial. **Please check in using Agility Gate – even from home. If you will be absent, please mark "scratch" for your dog on agility gate.**

Agility Gate is a free-to-download app that allows competitors to check-in their dogs via their mobile phone or tablet at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring.

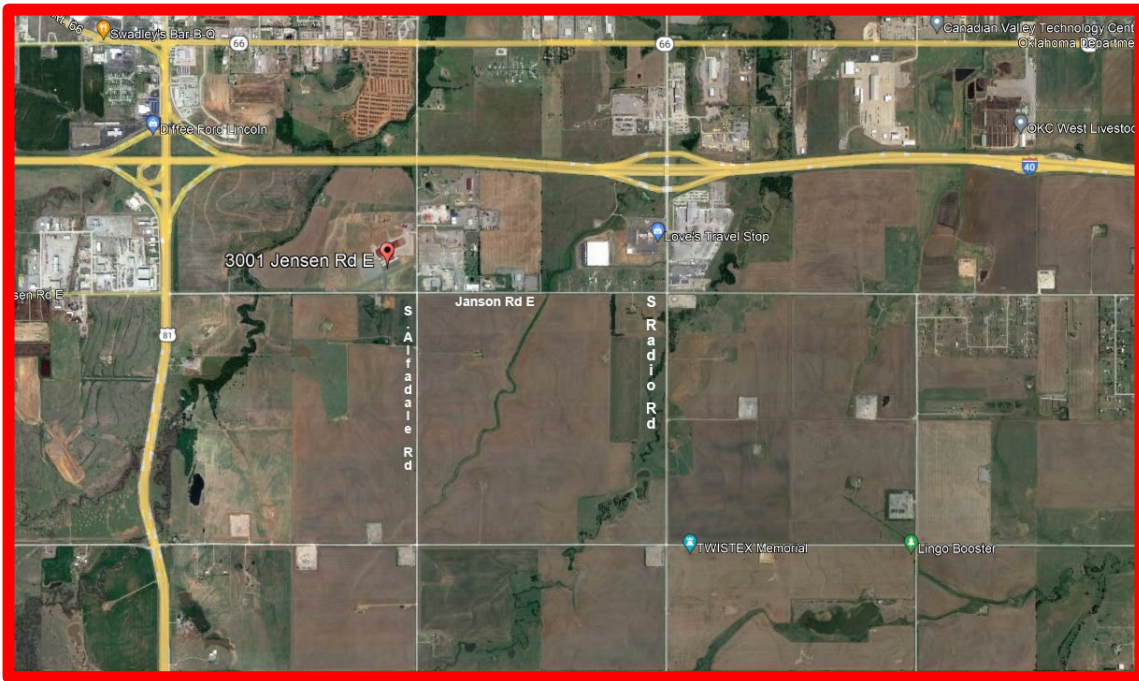

THE TRIAL SITE



EL Reno is approximately 20 miles west of Oklahoma City on I-40

- Follow I-40 W from OKC to S Radio Rd in El Reno.
- Take exit 127 toward S Radio Rd – Turn left on S. Radio Rd.
- Turn Right on Jensen Rd E
- Go past S. Alfadale Rd. to the entrance to facility on the right.

EXHIBITORS MUST ENTER from Jensen Rd. E. (See bottom map above)

OR – FOR RVs ONLY:

- From S Radio Rd., turn Right on Jensen Rd. E
- Turn right on S. Alfadale Rd.
- Show Site will be on the left in approximately .1 (one-tenth) mile.

RVs MUST ENTER FROM S. ALFADALE RD. (See bottom map above)

JUDGING SCHEDULE

Please notify the Gate Stewards of any running conflicts. Conflicts will be handled on a case-by-case basis when/if they occur. Class counts are contingent on move-ups not yet received and wait-list changes that have not yet been made.
Rings will run concurrently.

ALL TIMES (except for the starting times each day) ARE ESTIMATES.

TIMES ARE LISTED AS A COURTESY ONLY TO GIVE COMPETITORS AN IDEA OF WHEN THE CLASS WALK-THRUS COULD BEGIN.

Exhibitors are responsible for being at the ring when their turn is called.

Neither the Club nor the Judges will be responsible for the start times. Please plan your arrival accordingly.

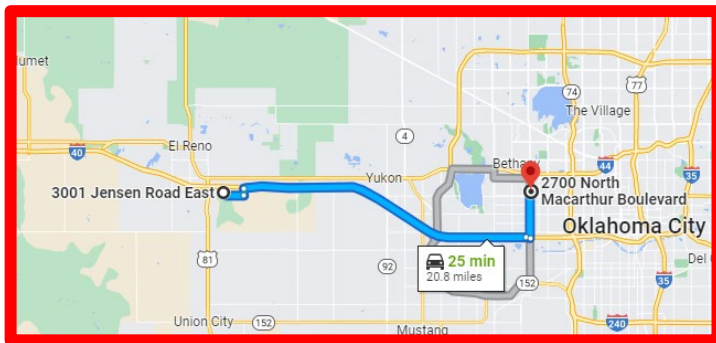

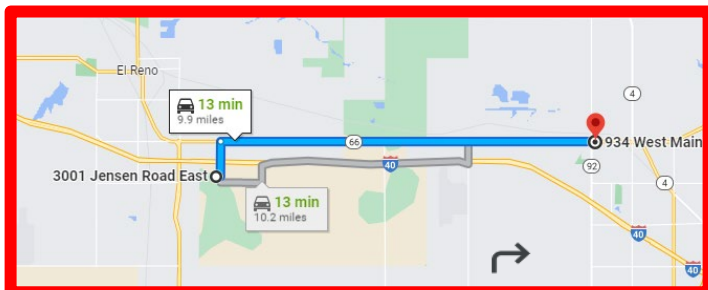

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels. Please clean up after your dogs (inside and outside), keep them quiet so as not to disturb other guests, and generally be considerate of others. We all want to continue to have nice places to stay when we travel with our dogs.



Exhibitors are expected to maintain hotel premises and their dogs in a quiet, clean and well-kept manner and for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities.

Complaints lodged against any exhibitor will be under the auspices of our Trial Committee and reported to the AKC. This is an AKC-supported measure.

There are 28 RV slips with 50AMP, 30AMP, 110V electrical connections, water and a dump site on site for \$35/night. All RVers should be prepared to use a 50 or 30 amp connection. You might need a 75' water hose and power cable.
