Measuring

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked. Don't forget to bring your height card in case someone asks for it.



There will not be a Measuring Official at this trial unless an AKC rep is present (not expected). Measurements will not be official -- it is only to make sure you are in the correct jump height for this weekend.

All exhibitors who checked on the entry form that their dog needs to be measured must be measured before running (unless you're jumping 24"). If you are entered in Novice or Open, you do not have to get there early to check-in. It will be open all day. We will do measurements before either Novice or Open.

It is the exhibitor's responsibility to have their dog measured prior to running.

Check-In

ARMBANDS NOT REQUIRED

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the mandatory use of identifying stickers/armbands worn by agility exhibitors. The Club is not requiring armband stickers.

Traditional check-in is not necessary. Please check in at the gate on the gate sheet prior to your class.

Dogs may not be left in the building overnight.

MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted

to the trial secretary via email **no later than** 6:00 PM Monday, August 5. Day-to-Day Move-Ups are permitted if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line to be moved-up for the following day.

The Arena will be available for exhibitor set up from 6:00 pm to 8:00 pm on Wednesday, August 8, and at **7:00 am** each day thereafter.



DIRECTIONS TO THE SHOW SITE:

From Hwy 84 (East or West) Take the US-385 ramp (south). Turn onto US-385/Hall Ave and continue south approximately 23 point 7 miles. When arriving at the Hwy 385/ FM 300 intersection, turn left. The Mallet Event Center will be on the right.

From 289 Loop in Lubbock Exit 19th street (Texas Highway 114 West.) Continue approximately 24.5 miles .Travel through town. When arriving at the Hwy 385/FM 300 intersection, turn left. The Mallet Event Center will be on the right.

From Brownfield Travel north on Hwy 385 towards Levelland. The Mallet Event Center will be on the left hand side of the road, across from the airport.

EXHIBITOR PARKING – Parking is free. Park at your own risk. PLEASE DO NOT leave dogs in any vehicle. The show committee reserves the right to break into any vehicle to rescue animals in distress.

EXHIBITOR CRATING; INDOOR SET UP RESTRICTIONS: All crating will be on dirt. Matting is allowed. No X-Pens allowed in the crating areas. Please cover crates to keep barking at a minimum. No high-backed (i.e. La Furna style) lounge chairs allowed at ring side.

ABSOLUTELY NO DOGS OFF-LEAD ON THE ENTIRE MALLET CENTER GROUNDS INCLUDING EMPTY PADDOCKS AND CORRALS. THE ONLY EXCEPTION IS AT THE PRACTICE JUMP AND IN THE RINGS. VIOLATORS WILL BE SUBJECT TO TRIAL COMMITTEE ACTION.

Exhibitors are expected to maintain hotel premises and their dogs in a quiet, clean and well-kept manner and for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities.

Complaints lodged against any exhibitor will be under the auspices of our Trial Committee and reported to the AKC. This is an AKC-supported measure.

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels. Please clean up after your dogs (inside and outside), keep them quiet so as not to disturb other guests, and generally be considerate of others. We all want to continue to have nice places to stay when we travel with our dogs.
