COVID GUIDELINES

IF YOU ARE EXPERIENCING ANY SYMPTOMS OF ILLNESS, please excuse yourself from the event.

MASKS AND SOCIAL DISTANCING:

Practice social distancing consistent with current guidelines with the State, County and AKC. Please keep 6' between your crate area and your neighbor's. We ask that **EVERYONE** have a mask with them at all times. As this is an outdoor trial, wearing them will not be required while social distancing is being practiced. However, you may find yourself in a situation (needing to talk with the judge, secretary or awards table) when you will need to be closer than 6'. Masks are not required while running your dog in the ring but are **MANDATORY during walk-throughs**. Walk-throughs will be split into groups of 25. Please be respectful of people's space, and their choices for protecting their health. If you forgot to bring a mask, please ask the trial chair for one.

HAND SANITIZER and disinfectant spray will be available ringside and around the trial property. There will be a **HAND WASHING STATION** by the Port-o-potties courtesy of North Texas Barnhunters.

CARRY YOUR OWN PEN whether you are working at the gate, or as a scribe. *Pro Tip:* affix an address label to it to identify it.

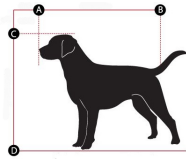

MEASURING



All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked.

Don't forget to bring your height card in case someone asks for it.

There will be not be a Measuring Official at this trial unless an AKC rep is present (not expected). Due to Covid-19, Measurements will not be taken at the trial.

CHECK-IN / ARMBANDS

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the mandatory use of identifying stickers/armbands worn by agility exhibitors. The Club is not requiring armband stickers.

Check in at the Award Tent on arrival. Please bring your completed COVID Waiver (included here) to the Awards Tent.

You will be checked in contact-free on all your appropriate gate sheets and receive your wristband. We will have a small gift for the first 75 exhibitors to check in.

ARRIVAL/SETUP

OBSERVE THE 5 MPH SPEED LIMIT ON EQUESTRIAN WAY. There is a \$100

fine for speeding. There will be no early exhibitor setup on Thursday, November 12 except for volunteers helping to unload the trailer at Noon. **You may set up on Thursday IF you help unload the trailer.** Tents and easy-ups are permitted throughout the site.



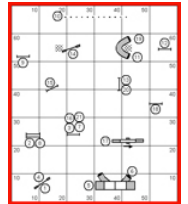
The gates open at 7:30 a.m. all three days.

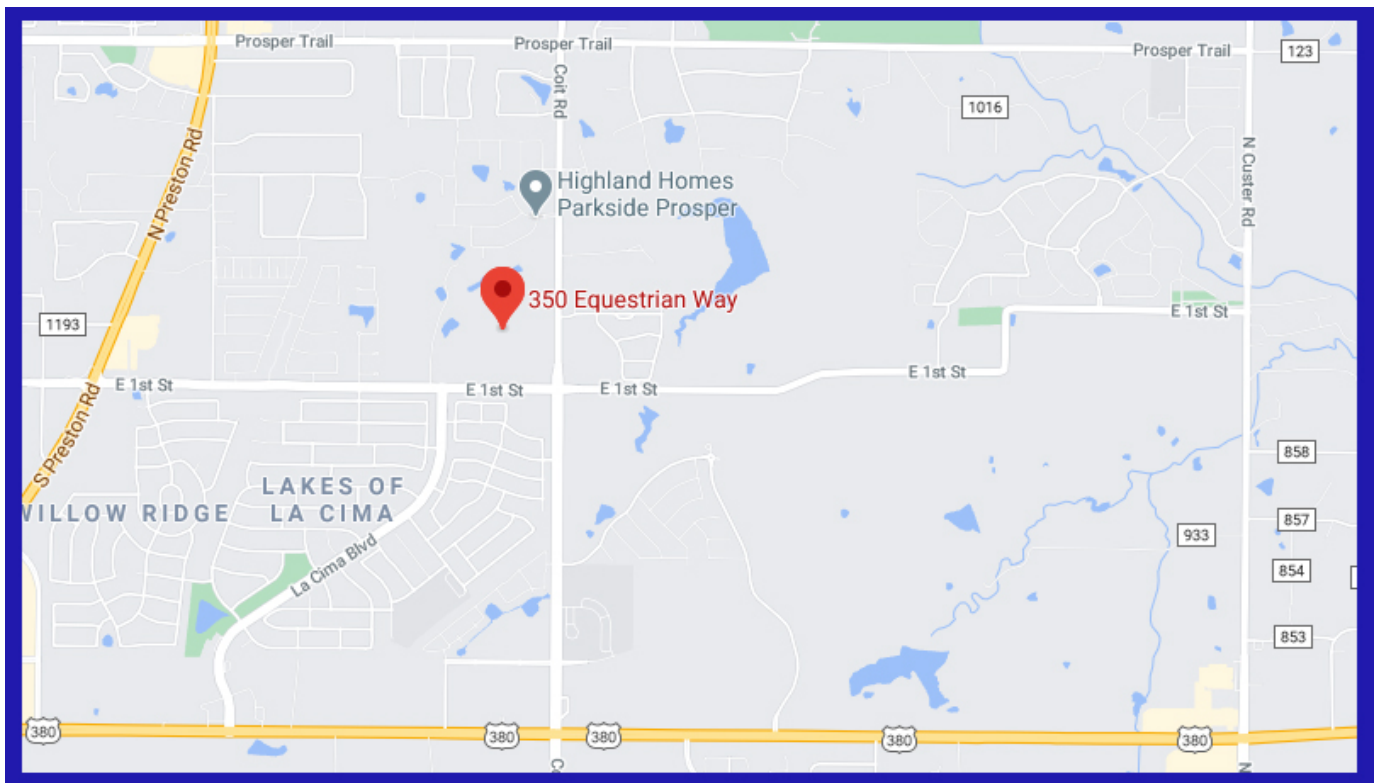
THE TRIAL SITE

Covid Guidelines and Information for Exhibitors and Volunteers attending the Dallas Agility Working Group trial November 13–15, 2020, at Prospering Paws, Prosper, TX

1. Clubs, officials and participants are required to follow state, local and facility. Please stay informed of updates https://www.collincountytx.gov/healthcare_services/Pages/publicguidance.aspx and <https://www.texas.gov/Covid19/>.
2. Practice social distancing consistent with current guidelines. Avoid congregating as much as possible. Avoid shaking hands and hugging.
3. Carry a mask with you at all times. Please wear it when in close proximity to others. If you do not have one, the Trial Chair will provide one for you. Masks are MANDATORY during walk-throughs. Masks are suggested for all Ring Crew.
4. Hand sanitizer stations will be available at ringside, along with disinfectant and wipes. There will be a hand washing station located by the Port-o-Potties, courtesy of North Texas Barn Hunters.
5. Avoid touching dogs that are not your responsibility.
6. Avoid common use pens/pencils – bring your own.
7. Crating should be at least six feet apart, except for “family” groups of exhibitors consisting of 10 or less.
8. Surfaces in common use areas will be disinfected as often as possible (tables, chairs, gate latches, etc.) If you are working in the ring, please consider using your own chair.
9. No shared food items are permitted. A food truck will be available on site, and there are many take-out options near the show site. Consider bringing your own refreshments. Bottled water will be provided for the Ring Crew in the Awards tent.
10. Park with sufficient distance between vehicles if possible. Consider crating from your vehicle.
11. Check in at the Award Tent on arrival. A volunteer will collect your completed COVID Waiver, mark you present on the appropriate gate sheets, and give you your wrist band.
12. Your Qualification Stickers will be placed in an envelope with your name on a board outside the tent. Awards will be distributed by the Awards Chair when requested. There will be no self-serve boxes.
13. Ring Tents – Each ring will have a tent that will house tables for the trial secretary, for the judge, and for the timer and scribe if needed. If you need to have interaction with any of them, please keep a distance of six feet, and be sure to have your mask with you.
14. Gate Steward should be provided at least a 6’ buffer and will be the only one to mark the gate board once they are at the ring entrance. Gate Steward will use their own pen/marker.
15. Leash Runner can either use paper towels to handle each leash; can apply hand sanitizer between handling of each leash; or use a “grabber”, which will be wiped down between leashes.
16. Course Builders will use hand sanitizer before and after setting courses. The measuring wheel will be wiped before/after each use. Only the Chief Course Builders will handle maps. DO NOT share course-building maps with others.

17. Timer/Scribe should sit at the ends of the table. The Scribe should only use their own pen. The table, timer console and chairs should be wiped down with each shift change. Scribe sheets will be placed in a basket that the Trial Secretary will retrieve.

18. Briefings may be done over a PA system/ring speaker so exhibitors may stay spread out. Exhibitors do not have to come into the ring for briefing – they may stay outside of the ring. Briefings will not be required for Excellent/Master level classes.

19. No measuring will be done by the judge of record. Should a VMO attend the trial, they may choose to not measure dogs. If they agree to, the measuring devices and table should be wiped down between dogs. VMO should consider wearing a mask and must sanitize their hands between dogs.

20. Walk-throughs will be split in groups of no more than 25 exhibitors. If there is more than one group for a class, the first dog is to be on the start line immediately after the last group walks. No 5-minute break.

21. Spacing for teams lining up will be marked with cones. The Gate Steward will announce the next three dogs in “Place One”, “Place Two” and “Place Three”.

22. Ring Crew designated as “Gate Opener/Closer” will open/close gates and sanitize gate/latch/hands as needed. Exhibitors are not to touch gates.

23. Results will be posted at the Awards Tent along with Course Maps, which will also be available at <https://ntxagility.com/> on the evening before the trail. It is recommended that on-site, exhibitors take pictures of the maps with their smart devices. There will be a limited number of course maps available for those that cannot take photos or do not have internet access.

24. Exhibitors may place leashes in their pockets when running the course or wear on themselves (i.e., clip like a belt around the waist). Note: if the dog grabs the leash while running this will be scored as an “E”.
