Measuring

All agility dogs are required to have an Official Jump Height Card and must be able

to present it if asked. Don't forget to bring your height card in case someone asks for it.

Our Judge, Randy Capsel, is a measuring official. ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. **Forms will be available at the table outside the trial secretary office. Please fill out a form before requesting to be measured.** Official

Measurements can be done throughout the day. It is the exhibitor's responsibility to have their dog measured prior to running.

Check-In

(Armbands Not Required)

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), the club will not be requiring the use of armband stickers, so traditional check-in is not required.

No paper check-in will be required. We will be using the **Agility Gate App** for check-in on your phone.... See Page 2 for more information.

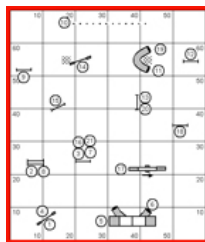
A running order will be posted at www.ntxagility.com 3-4 days prior to the first day of the trial.

It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring or away from the show site.

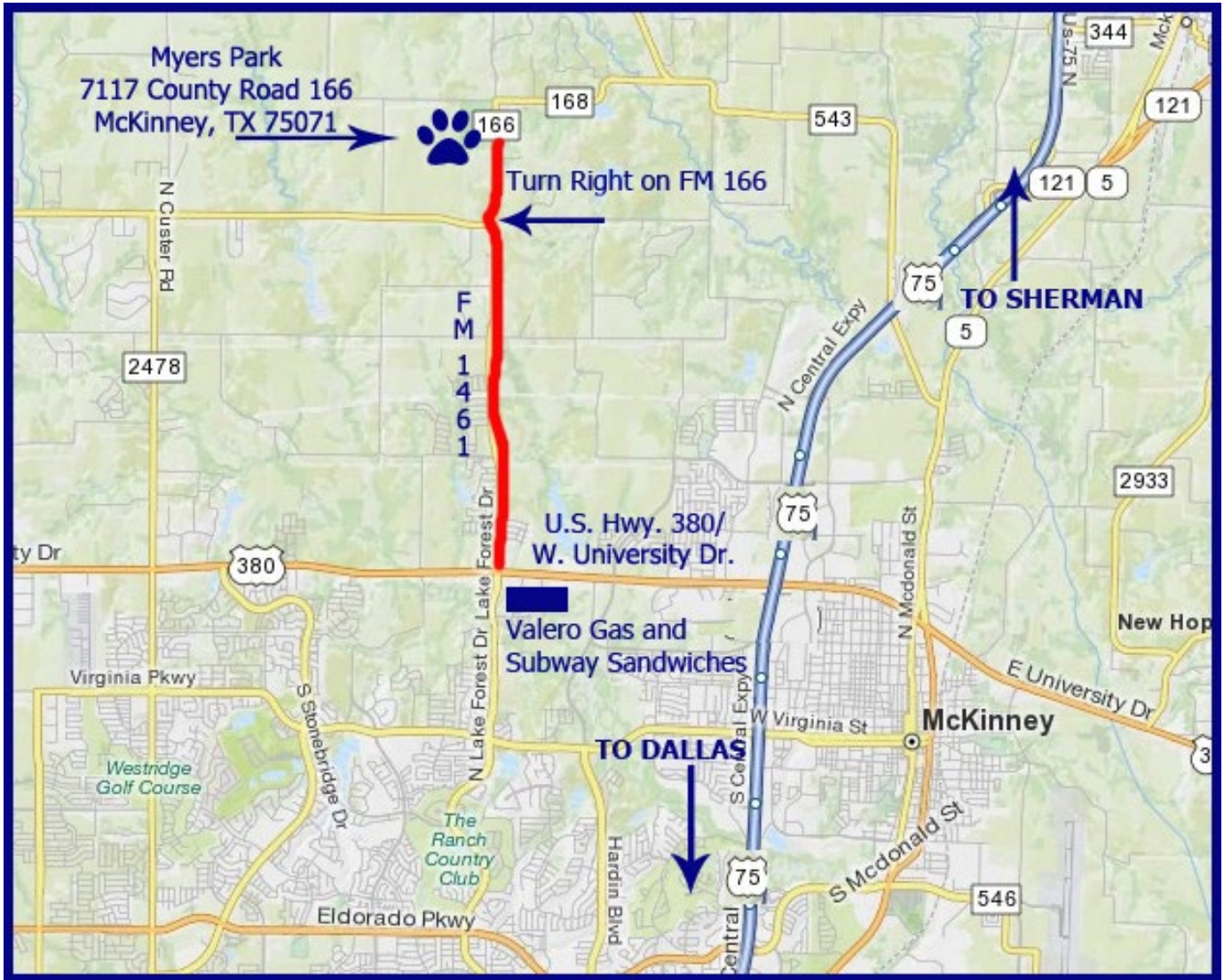

The Trial Site

The town of McKinney is about 33 miles north of downtown Dallas on U.S. 75/North Central Expressway. From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM1461. Turn right (north) on FM1461 and travel approximately 2.9 miles to County Road 166. Turn right (north) on County Road 166 and go .8 (8/10) mile to the site which



is on the left. The county has posted directional signs to the Event Center.

PLEASE BE AWARE....

Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damage to motels/hotels or the event site and may result in disciplinary action by the Event Committee. Entries may be refused in the future for previous misuse of the motel or show facilities. This is an AKC-supported measure.

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels.
