All agility dogs are required to have an Official Jump Height Card and must

be able to present it if asked. Don't forget to bring your height card in case someone asks for it.

There will be no measuring of dogs unless an AKC rep happens to come to the trial (not expected).

ARMBAND STICKERS NOT REQUIRED

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), DenTex will not be requiring the use of armband stickers, so traditional check-in is not required.

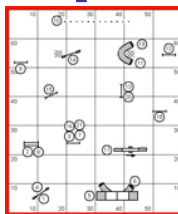
....Will be available during the trial. Breakfast and lunch will be served at the concession stand on the concourse level. Sorry, outside food is not allowed.

Arrival/Setup



There is no early set up on Friday. You may begin setting up at 6:30 am on Saturday and Sunday.

IMPORTANT: Unloading/Loading on Sat. & Sun. will NOT be permitted through the overhead door on the west side of the arena. Unloading/Loading will have to be done through the north doors/ramps to the arena on Burnett-Tandy Drive.

DIRECTIONS TO THE PARC: Exit the show site by going left on Trail Dr. Turn south (right) on University Dr to I-30 W. In approximately 8/10 of a mile, turn right onto West Freeway. Merge onto I-30 West. In approx. .23 miles, take Exit 10 toward Hulen St. Stay on West Freeway and exit (turn left) onto Merrick St. Turn left over freeway and turn left onto the Eastbound service road. The PARC is located on the south side of I-30 east of Merrick Street. (Approximately 5-10 minutes from show site).on the right.

The pretrial move-up deadline is Monday, June 14 at 6:00 pm. Please email the trial secretary on or before that date/time for a move up for the trial.

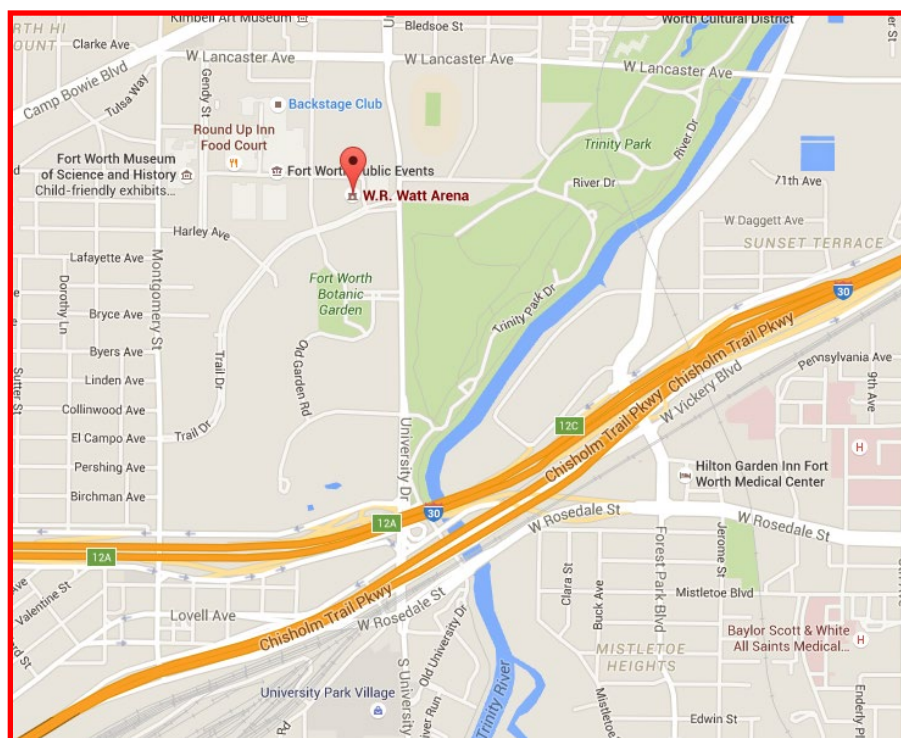
PARKING AT WATT ARENA

COVID GUIDELINES

- 1) Covid waivers will not be required at this trial, however, exhibitors are expected to not knowingly expose others to any illness they may have or are at risk of having been infected.
- 2) By attending this trial, exhibitors acknowledge they are attending at their own risk, and will not hold the AKC, Will Rogers Memorial Center, the City of Fort Worth, the Dalmatian Club of North Texas, club members, or volunteers liable for any present or future Covid-19 exposure.
- 3) Exhibitors are required to practice social distancing consistent with current guidelines. Avoid congregating as much as possible. Avoid shaking hands and hugging.
- 4) Masks are optional for fully-vaccinated people. If you feel uncomfortable, please feel free to wear your mask.
- 5) Hand sanitizer will be available at various locations, along with disinfectant and wipes.
- 6) Disposable gloves will be available for course builders, ring crew, and any other workers.
- 7) Avoid common use pens/pencils – bring your own. Individually wrapped pens will be available for scribes.
- 8) No MACH/PACH cakes or community shared food items at this trial.
- 9) The concession stand will be open for exhibitors.
- 10) Crating should be distanced as much as practical. Please use common sense.
- 11) The Agility Gate app will be used at this event. You will check yourself in on the app. The scribe or gate steward will be marking off people on the app when run is complete so exhibitors will see who is in next on your phone, your tablet or on the monitors outside the ring.
- 12) Leash runner will use a “grabber” to pick up leashes. The exhibitor may put their leash in a pocket or wear as a “belt” during their run.
- 13) Walk-thru groups will be divided into groups of 40 or less as needed.
- 14) There will be no judges’ briefing for the Excellent/Master/Premier/T2B classes. There will be a judges’ briefing for Novice, Open, and FAST classes.
- 15) Paper copies of maps will not be available. They will be posted at www.ntxagility.com each evening prior to the trial day and on Agility Gate. Maps will also be posted at the trial site for anyone who wishes to take pictures of them.
- 16) Qualifying labels will be self-serve. Please use hand sanitizer prior to removing your label from the sheet. Qualifying ribbons, placement rosettes and new title ribbons will be placed on a table near the trial secretary for pick up.
- 17) Results will be posted at the trial site on the day-of and posted at www.ntxagility.com each evening of the trial.
- 18) Please wash and sanitize your hands often.
