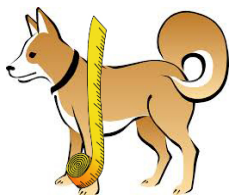

Measuring

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked. Don't forget to bring your height card in case someone asks for it.



There will be not be a Measuring Official at this trial unless an AKC rep is present (not expected). Measurements will not be official -- it is only to make sure you are in the correct jump height for this weekend. All exhibitors who checked on the entry form that their dog needs to be measured must be measured before running (unless you're jumping 24"). If you are entered in Novice or Open, you do not have to get there early to check-in. It will be open all day. We will do measurements before either Novice or Open.

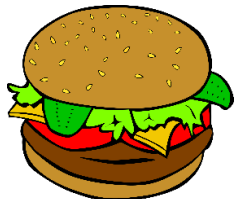
It is the exhibitor's responsibility to have their dog measured prior to running.

A NOTE ABOUT THE RUNNING ORDER....

PLEASE be sure to check the running order for each day very carefully. Saturday's running order is a bit different in T2B and FAST because the trial filled and we have to load balance to get closer to each judge's maximum number of runs. **CHECK SATURDAY'S T2B AND FAST RUNNING ORDER CAREFULLY.**

It is VERY IMPORTANT for you to check the running order for EACH DAY to make sure you don't miss any runs!

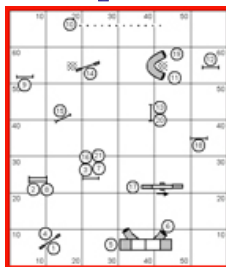
Concessions...

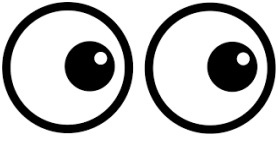

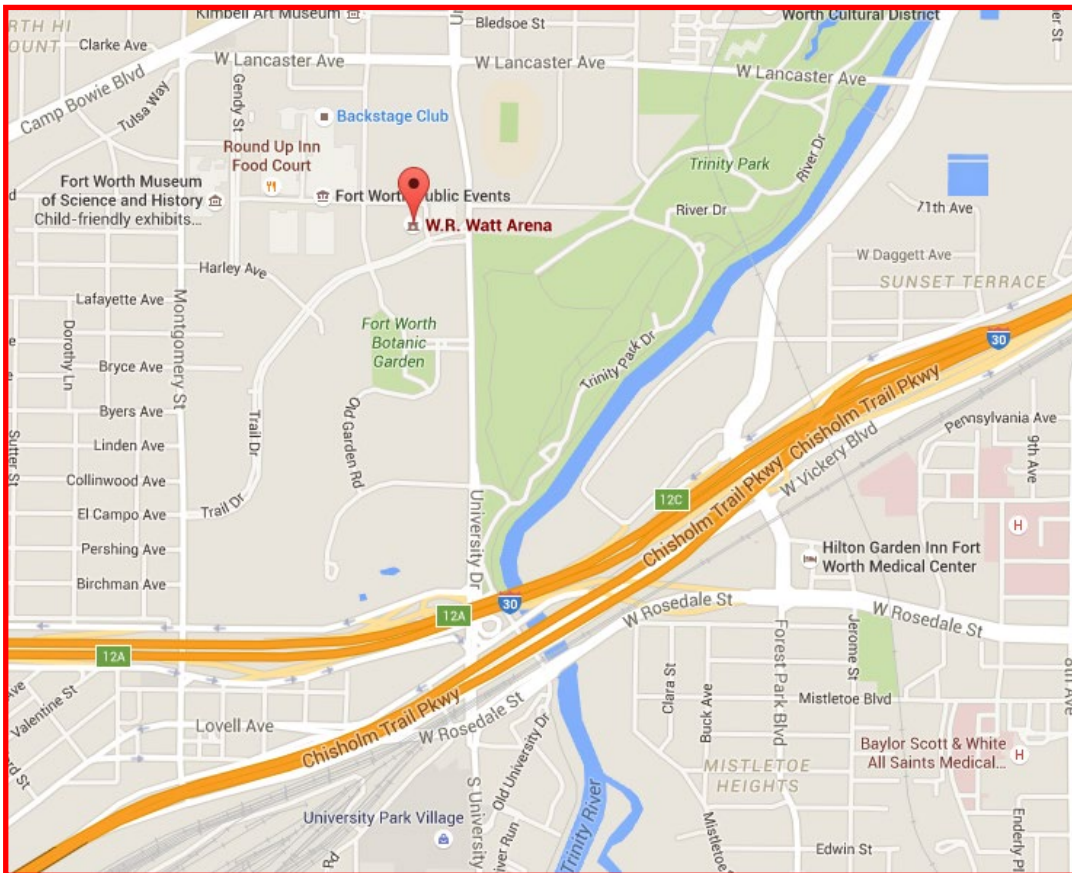
PARKING AT WATT ARENA

Please do not leave dogs or any valuables in your vehicle at any time. The Trial Committee reserves the right to take whatever measures are necessary to rescue animals in distress.** Purchase your daily or multi-day parking pass at the gate.

Security & RV Parking: Please see information below on RV/motor homes. **Dogs may NOT be left in the building overnight.**

The Trial Site

From Interstate 30 just west of downtown Fort Worth, take the UNIVERSITY DR NORTH ramp around and turn left (North) on University Drive. Go .6 miles (6/10 of a mile) to the light at Harley Drive. Turn left onto Harley Drive. The building ahead on the right is Watt Arena.



RV PARKING

There are RV hookups and a dump station in the lot south of Harley at Montgomery Street and in the area next to the Swine Building; **NO RESERVATIONS** – first come, first served. Contact Will Rogers Memorial Complex, Amon Carter Square, Fort Worth TX 76107, 817.871.8150, for information & payment. All vehicles larger than a standard van must park in the lots one block south of the Museum of Science and History on Harley/Montgomery Streets. The area next to the Swine Building is paid RV parking **ONLY**. RV lots on Harley Street and west of the Swine Barn will have water and hookups. Parking on marked lots must be inside the designated lines.
