# Measuring

All agility dogs are required to have an Official Jump Height Card and must be able to present it if

asked. Don't forget to bring your height card in case someone asks for it.

Both judges are measuring officials. Get both measurements (if needed) this weekend! All dogs over 2 years old without a permanent height card and dogs under 2 years old without a yellow temporary measurement sheet must be measured before running. Measurements will be done all day between classes.

It is the exhibitor's responsibility to have their dog measured prior to running.

# (Armbands Not Required)

Pursuant to Chapter 1. Section 19 of the Regulations for Agility Trials (Revised July 2016), DenTex will not be requiring the use of armband stickers, so traditional check-in is not required.

Be sure to check in on the Gate Sheet in your ring prior to running.

Turn right (north) on FM1461 and travel approximately 2.9 miles to County Road 166. Turn right (north) on County Road 166 and go .8 (8/10) mile to the site which is on the left. The county has posted directional signs to the Event Center.
