


Exhibitors should follow their veterinarian's recommendations to assure their dogs have appropriate vaccinations and are free of communicable diseases and internal and/or external parasites.

Directions to Trial Site

From McKinney, TX - US 75 (Central Expressway) at Hwy. 380: Travel west on Hwy, 380 (University Dr.) 15 miles to FM 1385. Turn right on FM 1385. Travel 5.3 miles to FM 428 W and turn left. Travel 2.7 miles to FM 2931/FM 2831 and turn right. Travel 1/8 of a mle to E Blackjack Rd E and turn left. Travel 1 mile. Kreuzung Dog Coach is on the right. VERY IMPORTANT: Do NOT go over 5 mph down the driveway past the house. The training building is behind the house.



From Dallas – Traveling North on I-35 toward Denton, exit on Loop 288 N. Travel 3.2 miles and turn right on Prominence Pkwy and travel 4/10 of a mile to N. Mayhill Rd and turn left. Travel ½ mile and turn right on US 377 E/University Drive. Travel 4 miles and take a slight right to US 377 N. Travel 5.5 miles and turn right on E. Blackjack Rd. E. Travel 1.3 miles. Kreuzung Dog Coach is on the left. VERY IMPORTANT: Do NOT go over 5 mph down the driveway past the house. The training building is behind the house.

CRATING

- ★ Indoor crating is VERY limited. Workers get priority on indoor crating space.
- ★ LSDOC reserves the right to ask exhibitors to stack crates and limit chairs if the need for more space is required. Large lounge-type chairs are not allowed inside the building.
- ★ Mats are NOT allowed if you are crating inside. Chairs will be allowed only if space is available. Spectator chairs will be allowed ringside as long as they don't impede or interfere with foot traffic and space is available. LSDOC reserves the right to ask for chairs to be removed. Failure to comply can result in a committee hearing. All chairs MUST have rubber caps on each leg to protect the mats or have a cardboard square (provided if needed) under each leg.
- ★ Exercise pens are not permitted inside. All dogs who are not being warmed up, shown, or "pottied" must be securely crated.
- Additional crating space is available under cover on dirt outside the door to the ring area. The outdoor crating area has a very large overhead fan (Big Ass Fan) and sunscreens for added comfort. Car crating is very convenient.

Notices to Exhibitors

IF YOUR DOG IS ILL OR EXHIBITING ANY SIGNS OF ILLNESS INCLUDING, BUT NOT LIMITED TO, COUGHING, DIARRHEA, OR RESPIRATORY DISTRESS, PLEASE LEAVE THEM AT HOME. ANYONE NOTICING A DOG EXHIBITING SIGNS OF ILLNESS IS REQUIRED TO REPORT IT TO THE EVENT COMMITTEE. ILL DOGS WILL BE IMMEDIATELY EXCUSED AND WILL NOT BE ALLOWED TO STAY ON THE SHOW GROUNDS. A MISCONDUCT HEARING COULD BE HELD FOR ANYONE INTENTIONALLY DISRESPECTING THIS REQUIREMENT.

Bitches in season are not permitted to compete or be on the trial grounds. If a female is withdrawn from competition because she came into season, the trial secretary must be notified in writing no later than one-half hour prior to the start of the first class in the trial. The club will refund the entry fee, less \$5.00 (per trial) processing fee upon written certification by a veterinarian given to the Trial Secretary before the start of judging each day.

Exhibitors are responsible for the behavior of their dogs. All dogs present must be confined to their crates except when being pottied, warmed up, or judged. Dogs being pottied or warmed up must be held on lead. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dog creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, refund of any entry fees will not be made.

Handlers WITHOUT DOGS are welcome at ringside to watch Rally Trial judging. The Rally Trial Committee Members will remind anyone at ringside with a dog that their dog must be crated while the handler is watching judging. The ring entrance and exit must be clear at all times. The Rally Trial Committee is committed to the safety of all dogs and handlers, and we thank you in advance for your support.

Exhibitors and guests are responsible for the behavior of any child(ren) who accompanied them. Any exhibitor or guest whose child or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made. The Club and the Trial Facility assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children.

The Judge will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Dogs may arrive one hour prior to their scheduled time of judging. Dogs not required for further judging may be excused.

Pinch/prong and electrical collars (dummy or not) are not allowed on trial grounds.

The Club and the Trial Secretary have no obligation or responsibility to provide a public address system or stewards to call or locate dogs that are not present at the ring when required. Exhibitors are responsible for being at the ring when it is their turn to run.

DO NOT LEAVE DOGS IN CLOSED VEHICLES. If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Event Committee for disciplinary action. The event committee reserves the right to break into a vehicle to rescue a dog in distress. All persons attending these events hereby waive any claim for damages against the host clubs, its members, Show Secretary, or the property owner in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.



IMPORTANT INFO... Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities. This is an AKC-supported measure.

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels. Please clean up after your dogs (inside and outside), keep them quiet so as not to disturb other guests, and generally be considerate of others. We all want to continue to have nice places to stay when we travel with our dogs.
