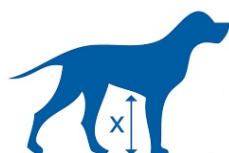

Measuring



During the COVID pandemic, AKC is not requiring dogs to be measured prior to running.

Check-In

ARMBANDS NOT REQUIRED

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the mandatory use of identifying stickers/armbands worn by agility exhibitors. The Club is not requiring armband stickers.

Traditional check-in is not necessary. Please check in on the gate sheet prior to your class. **PLEASE BRING YOUR OWN PEN TO CHECK IN. NO COMMUNITY PENS WILL BE AVAILABLE.**

CONCESSIONS

There will not be a concession stand, but there will be a food truck available on Saturday and Sunday. We encourage you to bring your own food, drinks and snacks on Friday and try out the food truck on Saturday and Sunday.

A short devotional will be held on Sunday morning prior to the start of the trial.

Dogs may not be left in the building overnight.

MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the trial secretary via email **no later than Monday, November 30, 2020 at 6:00 pm.** **Day-to-Day**

Move-Ups are permitted if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Friday for a Saturday move-up or on Saturday for a Sunday move-up.



Arrival & Setup

Set-up will be allowed on Thursday from 2:00 pm until 5:00 pm, on

Friday beginning at 10:00 am, at 7:30 am on Saturday and at 6:30 am on Sunday.

The trial starts at noon on Friday.

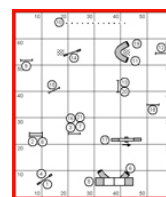

From the show site, get on US 281 North for 1.9 miles. Take the exit toward TX-79 S/TX369/Southwest Pkwy and merge onto Henry S Grace Fwy. Turn left onto the TX-79 S ramp to TX-369 N. Keep left to continue on Southwest Pkwy and travel 1.7 miles. Turn right onto Taft Blvd. Colonial Park Vet Clinic is .2 miles. 6 minute travel time.

Running Order & Course Maps

COVID Guidelines

Obedience Training Club of Wichita Falls would like everyone to know we are working on making sure we are providing a safe environment consistent with current guidelines.

Practice social distancing consistent with current guidelines.

Please keep **6 feet** between crates.

Everyone must wear a mask except when running your dog.

Disposable gloves will be available to course builders, ring crew and any other workers that desire them. We also will have disposable mask available if needed.

Hand sanitizer and disinfecting spray bottles will be available around the arena.

There will be no common use writing utensils. **Please bring your own pen.**

There will be no MACH cakes or community shared food items at the trial. There will be water and some snacks provided for workers.

There will be no self-serve ribbons. We will have a volunteer putting the sticker on the ribbons for you. Please let our volunteer know if you only want the sticker.

There will be a 6-foot area marked off around the gate steward. Please do not go into this area.

Once the running order is placed at the ring entrance, and the gate steward is in their designated space, he/she will be the only one to mark on the board. The gate steward will be in charge of getting the dogs in the correct order to enter the ring. There will be a designated area for "on deck", "in-the-hole", and "3rd in line". No congregating will be allowed in the ring area. A few people will be allowed to video.

Leash runner will use a "grabber" to pick up leashes. The leash "grabber" will be disinfected after each run.

Course builders should wipe down the measuring wheel before and after each use. They should not share course building maps.

Timer and Scribe will sit at opposite ends of the table. Scribe should use their own pen for marking scribe sheets. The table, chairs and timing console will be wiped down with disinfectant after each group of workers.

There will be no judges briefing for the Excellent/Master/premier/T2B classes. There will be a judge's briefing before all Novice, Open and Fast classes.

Walk-thru group sizes will be reduced.

Please do not crowd around the results area. Results from the day before will be posted on the ntxagility.com website each evening. They will not be put in a notebook.

Course maps will be posted per AKC Agility Regulations. There will be no printed copies of course maps for exhibitors. Exhibitors may take a picture of the posted course maps. In addition to the course maps that are posted at the trial site, the trial secretary will post the maps to her website the evening before each day of the trial. You can use your phone or iPad to view the maps. www.ntxagility.com

Please be diligent in washing and sanitizing your hands.

The Trial Site

From the south on Hwy. 287: Take the left at the fork to TX-79 S, follow signs for US 281 S/Jacksboro/Archer City. Cowboy Church will be 3.8 miles down on your left.

From the north on Hwys. 287 or I-44: Past downtown Wichita Falls, use the left 2 lanes to take the US-281 S/TX-79 S exit toward Jacksboro/Archer City. Cowboy Church will be 3.8 miles down on your left.

CRATING IS AVAILABLE IN YOUR CAR, ON CONCRETE OR ON DIRT. FANS AND/OR HEATERS ARE ALLOWED.

A short devotional will be held on Sunday morning prior to the start of the trial.

Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds.
