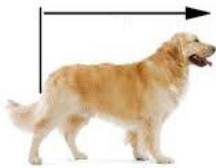

CHECK IN & MEASUREMENTS



All agility dogs are required to have an Official Jump Height Card.

There will not be a measuring official at the trial unless an AKC Rep attends (not expected). The judge will do measurements for the weekend only. These measurements will only be valid for this weekend. ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it.

If your dog needs to be measured, it is your responsibility to have it done before you run.

Check-In

ARMBANDS NOT REQUIRED

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the mandatory use of identifying stickers/armbands worn by agility exhibitors. The Club is not requiring armband stickers.

Traditional check-in is not necessary. Please check in on the gate sheet prior to your class.

Arrival & Setup

Set-up will be allowed on Thursday from 3:00 pm until 7:00 pm. Set up begins at 6:30 am each day.



MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted

to the trial secretary via email **no later than Monday, October 17, 2022 at 6:00 pm.** **Day-to-Day Move-Ups are permitted** if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Friday for a Saturday move-up or on Saturday for a Sunday move-up.

From the show site, get on US 281 North for 1.9 miles. Take the exit toward TX-79 S/TX369/Southwest Pkwy and merge onto Henry S Grace Fwy. Turn left onto the TX-79 S ramp to TX-369 N. Keep left to continue on Southwest Pkwy and travel 1.7 miles. Turn right onto Taft Blvd. Colonial Park Vet Clinic is .2 miles. 6 minute travel time.

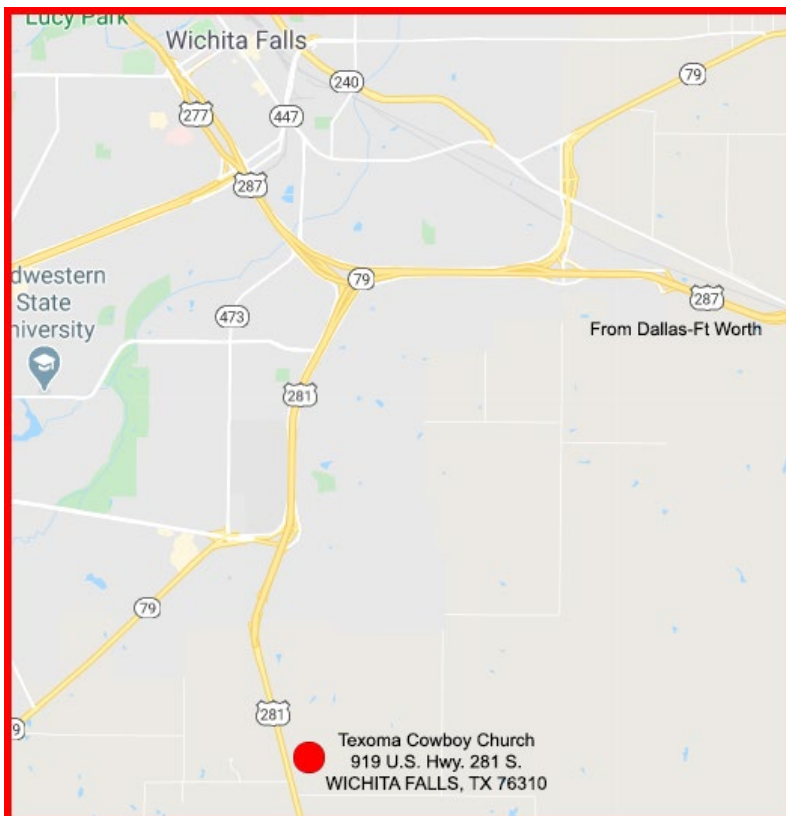


The Trial Site

From the south on Hwy. 287: Take the left at the fork to TX-79 S, follow signs for US 281 S/Jacksboro/Archer City. Cowboy Church will be 3.8 miles down on your left.

From the north on Hwys. 287 or I-44: Past downtown Wichita Falls, use the left 2 lanes to take the US-281 S/TX-79 S exit toward Jacksboro/Archer City. Cowboy Church will be 3.8 miles down on your left.

IMPORTANT INFO...



Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities. This is an AKC-supported measure.

PLEASE REMEMBER: Hotels do not have to allow us to keep our dogs in the rooms. We are all responsible for insuring future pet acceptance at our favorite hotels. Please clean up after your dogs (inside and outside), keep them quiet so as not to disturb other guests, and generally be considerate of others. We all want to continue to have nice places to stay when we travel with our dogs.
