A processing fee of \$5.00 per entry will be retained by the Club.

**WAIT LIST:** AKC rules limits entries to not exceed 8 hours of judging per day. However, a wait list will be established in order to fill all entries that are withdrawn prior to the close of entries.

**TRANSFERS** will be allowed at these Obedience Trials and Rally Trials per AKC Regulations. Please send pre-trial transfer requests to the trial secretary (email is acceptable) **no later than 6:00 pm on Monday, April 13.** Day-of transfer requests should be given to the Trial Secretary in writing **no later than 20 minutes after the end of the trial day.**

• **ATTENTION EXHIBITORS** •

For purposes of these trials, the Fannin County Multi-Purpose Complex with the surrounding grounds is considered trial grounds. As such, any damage or disrepair caused by exhibitors or their dogs to these properties will result in an Event Committee Hearing and may result in disciplinary action.

• **THESE ARE SELF CLEANING SHOWS** •

We ask for your cooperation with cleaning up after yourselves and your dogs.

NOTICE: Please have proof of trial entry as presentation to trial committee may be required. Any exhibitor disregarding or arguing with trial committee members or exhibiting unsportsmanlike behavior or violating any trial or AKC rule will be subject to Event Committee jurisdiction.

### SITE AVAILABILITY:

1. The Trial Site will be available to exhibitors beginning at Noon on Thursday, April 16, 2026. Dogs must be removed from the trial site immediately following the awarding of High in Trial or the conclusion of all judging (whichever is later) on Sunday, April 19, 2026.
2. The warm-up ring opens at 6:45 am each day.
3. The Building will be closed no later than 8:30 PM, locked no later than 9:00 PM and opened at 6:30 AM for exhibitors all days of the trials. **ABSOLUTELY NO DOGS MAY BE LEFT IN THE BUILDING OVERNIGHT.**

### ACCESS & PARKING:

#### UNLOADING & LOADING

1. The Complex unloading and loading should be done at the North, South or West entrances.
  - The North entrance is most convenient to the Rally Ring and the crating areas surrounding the Rally Ring.
  - The South entrance is most convenient to the two Obedience Rings and the crating areas directly across from the Obedience Rings.
  - The West (canopied) double door entrance provides convenient access to the Rally Ring, the Obedience Rings and to all crating areas.
2. **Please be courteous and REMOVE YOUR VEHICLE WHEN UNLOADING IS COMPLETED.** Equipment set up can be done after the vehicle has been removed.

#### PARKING

1. Parking is provided on a first come, first served basis at **NO CHARGE**.
2. Approximately 150 parking spaces are available on the North and West sides of The Complex.
3. All vehicles will be parked at owner's risk.
4. Unlawfully parked vehicles will be towed at owner's expense.
5. All vehicles must be removed from The Complex immediately following the awarding of High in Trial or the conclusion of all judging (whichever is later) on Sunday, April 19, 2026.

#### EXHIBITORS WITH DOGS ACCESS

1. During trial hours, exhibitors with dogs may enter and exit the building through the North, South and West entrances. **Please be considerate to not disturb dogs in the rings when entering/exiting the building.**
2. **Dogs are NOT ALLOWED in the Kitchen/Hospitality area or in the Judges Hospitality area.**
3. **DOGS MUST BE UNDER COMPLETE CONTROL** at all times, whether entering or exiting the building or on the trial grounds.
4. It is understood that exhibitors alone are responsible for the behavior of their dogs. Any exhibitor whose dog creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the site. In such case, no refund of any entry fees will be made.

#### CRATING AREAS:

1. The Trial Committee will mark and monitor the designated crating areas for all exhibitors.
2. **ONLY** the designated and approved crating areas may be used by Obedience and Rally exhibitors.
3. Crates may be left in the designated crating areas for the duration of the trials, but exhibitors do so at their own risk. The Club assumes no responsibility for any loss or damage sustained to exhibitor property.
4. **ABSOLUTELY NO CRATING OR CHAIRS ARE ALLOWED IN THE AISLES.**
5. Roping off or in any way reserving unused crating space is **STRICTLY PROHIBITED**.
6. **SOFT - SIDED** crates will be allowed, however they cannot be stacked.



7. Exhibitor's personal-standard size folding chairs (approximately 24" X 24") will be allowed in the crating areas and in the marked and designated chair spaces at ringside.
8. **AISLES MUST BE KEPT CLEAR AT ALL TIMES.**
9. Removing ringside facility chairs for use in the crating areas is not allowed.
10. Each exhibitor is responsible for cleaning his crating area and disposing of any waste daily.
11. The Trial Committee reserves the right to require the stacking of crates (except soft-sided), limiting the use of personal chairs in the crating areas or any other remedies it may deem necessary for consolidating crating space on a case-by-case basis at their discretion.

#### **DOGS ON SITE:**

1. NO dogs under 6 months of age are allowed on the trial grounds.
2. **Bitches in season and sick dogs are NOT allowed on the trial grounds. IF YOUR DOG OR ANY DOG IN YOUR HOUSEHOLD IS COUGHING OR SHOWING SIGNS OF ANY ILLNESS, PLEASE DON'T ATTEND. DOGS SHOWING SIGNS OF ILLNESS AT THE SHOW SITE WILL BE ASKED TO LEAVE.**
3. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
4. Collars must comply with AKC Regulations.
5. There WILL NOT be space for unentered dogs at these trials.
6. **Dogs must be securely leashed or crated (contained) at all times, except when in the Exhibit Rings or in the warm-up ring.**
7. **NO working or training of dogs in the Exhibit Rings before or after show hours is allowed, except during the approved "OC" Matches.**
8. **Warm-Up Ring will be run in accordance to AKC Obedience Regulations Chapter 1, Section 33 and the written procedures will be posted at the Warm-Up Ring along with a sign up sheet.**
9. **NO OFF-LEASH working or training of dogs in the building aisles at any time.**
10. **NO working or training of dogs, on or off leash, in the Holiday Inn Express & Suites Host Hotel hallways.**
11. NO dogs are allowed in restrooms.
12. **DO NOT leave any dogs in closed vehicles. The Club reserves the right to remove any dogs in distress found in vehicles by any means necessary for the welfare of the animals.**

#### **EXERCISING DOGS AT SITE:**

1. **THESE ARE SELF CLEANING TRIALS.** Although trash receptacles, clean-up equipment and plastic bags will be provided, it is the responsibility of each exhibitor to bring your own tools for clean-up after your dogs.
2. **DESIGNATED EXERCISE AREAS** are located in the large grass fields just beyond the parking areas west and north of the facility. The large open grass fields to the far west and far north sides of the facility are also available for exercising dogs on long lines or flexi leashes. The large grassy area immediately east of the building which extends east of the north parking area is available for exercising dogs, as well. Please dispose of waste properly in the outside receptacles that are provided around The Complex.
3. **DO NOT** exercise dogs in the grass immediately adjacent to the north, west and south exterior walls of the building.
4. **ABSOLUTELY** do not allow dogs to urinate on interior facility walls, posts, ring gates or trash cans or exterior walls or posts.

### **CHILDREN AT SITE:**

1. NO BUGGIES OR STROLLERS ARE ALLOWED.
2. Children in harnesses or similar devices must be kept close at the side of the supervising adult.
3. The parents or supervising adult will be solely responsible for the behavior, welfare and safety of their children and any damages caused by their children. Parents whose children create unnecessary disturbances or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave The Complex.
4. NO unaccompanied children will be allowed entry into the trial building.

### **SECURITY:**

1. Security will NOT be provided.
2. The Lone Star Dog Obedience Club, Inc., the Trial Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property, and further assume no responsibility for injury to children or damage caused by a dog.
3. All persons attending these dog trials, hereby waive any claims for damages against the Lone Star Dog Obedience Club, Inc., the Trial Secretary or their members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper or inadequate ventilation.

### **BUILDING RULES:**

1. The entire Fannin County Multi-Purpose Complex is a **NON-SMOKING** and **ALCOHOL-FREE** complex. Smoking is prohibited inside the building and within 20 feet of a building entrance. Consumption of alcohol is not allowed in the MPC building or in the parking lot.
2. Alterations of any kind that could mar or deface The Complex are **NOT ALLOWED**.
3. Nails, hooks, tacks, screws or any other hardware cannot be driven or installed into any part of The Complex. Altering the structure of the facility is **ABSOLUTELY NOT PERMITTED**.
4. No flammable materials such as bunting, tissue paper, crepe paper, etc. are permitted. Candles, if used, must be in approved containers.
5. Helium balloons are NOT allowed in the facility.
6. Skates (including shoes with rollers), skateboards & scooters or golf carts are not allowed, with the exception of ADA approved aids.
7. Dumping dog food in the restroom sinks or toilets is **STRICTLY PROHIBITED**.

### ***• ADDITIONAL NOTICES, ENTRY INFORMATION AND REFUNDS •***

1. Lone Star Dog Obedience Club members, officers and directors, excluding the Judges Selection Committee Chairman, may enter and exhibit dogs at these Obedience and Rally Trials. The Trial Secretary may also enter and exhibit dogs at these trials.
2. Exhibitors, alone, are responsible for being at the ring gate when it is their dog's time to run. The Judge is not required to wait for any dog holding up a class; nor will the Club or the Trial Secretary be obligated to furnish any service to notify exhibitors of judging.
3. Dogs need be present only for scheduled judging and will be released if not needed for further judging.
4. No entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.

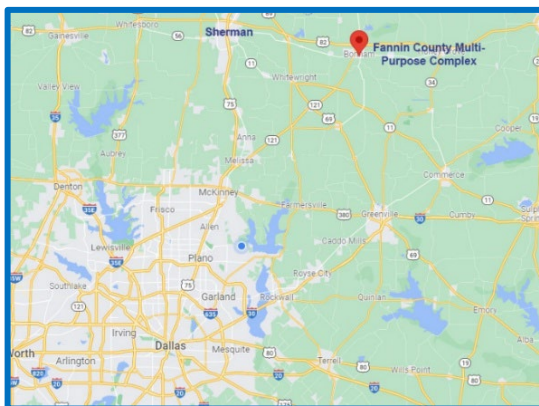

Preface: The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.
