The order of the classes both days will be: Master, Excellent B, Advanced B for both trials.

A lunch break will be taken between the 2 trials.

**TRANSFERS**

- ★ Transfers will be allowed in accordance with AKC regulations.
- ★ Notices of Transfers prior to the trial weekend are encouraged. Please notify the trial secretary (email is acceptable) on or about 6:00 p.m. on Monday, May 25, 2026.
- ★ Transfers may be approved provided the class is scheduled, the judge is available, and the class has not reached its limit.
- ★ Any requests for transfers between trials must be received in writing no later than 30 minutes prior to the start of the next trial.

**TRIAL HOURS**

7:00 am to 7:00 pm CST. The building opens for set-up at 7:00 a.m. on Sunday.

**Runs will start no earlier than 8:00 am.** Saturday Set-Up Is Not Available.

**WAIT LIST**

The Trial Secretary will establish a wait list in order to fill openings created by entries that are withdrawn prior to **6:00 pm on the Sunday prior to the trial**. All entries must be received prior to the closing date and time. The full entry fee shall be refunded to an entrant whose entry is replaced by a wait-listed entry. **Conditional entries cannot be accepted, i.e., "If I can't get in for both trials, I don't want to be in any trials."** Wait-listed entries will be filled in order of receipt on a per-run basis.

## **CRATING AND PARKING-IMPORTANT!**

- ★ Indoor crating is VERY limited. Workers get priority on indoor crating space. **Most crating must be from your car.**
- ★ LSDOC reserves the right to ask exhibitors to stack crates and limit (or prohibit) personal chairs. A limited number of chairs are provided.
- ★ Mats are NOT allowed if you are crating inside. Chairs will be allowed only if space is available. LSDOC reserves the right to ask for chairs to be removed. Failure to comply can result in a committee hearing. All chairs MUST have rubber caps on each leg to protect the mats or have a cardboard square (provided if needed) under each leg.
- ★ Exercise pens are not permitted inside. All dogs who are not being warmed up, shown, or “pottied” must be securely crated.
- ★ LSDOC encourages and reserves the right to require car crating.
- ★ **Parking** in the field caddy-cornered to the building is allowed unless it rains. If the field is wet, park at your own risk of getting stuck. LSDOC does not have equipment to pull vehicles out if they get stuck in mud. Head-In parking is allowed along the West side of the driveway and in front of the residence (head-in) as long as ingress and egress is not blocked. Exhibitors are required to follow the direction of a parking attendant, if one is present. **PARKING IS NOT ALLOWED ON THE PROPERTY DIRECTLY SOUTH OF THE BUILDING ON THE EAST SIDE OF THE DRIVEWAY.**


Take Parker Road Exit from Central Expy and turn East.

## Notices to Exhibitors

**If a legible email address is provided, confirmations, the Judging Program and the Schedule will be emailed.** Paper copies will only be mailed at the request of the exhibitor. Should a confirmation not be received by the exhibitor within a reasonable time, please notify the Trial Secretary at 972-841-4066 or email [trialsecretary@ntxagility.com](mailto:trialsecretary@ntxagility.com). **Please include a self-addressed, stamped envelope with your entry if you are requesting a paper confirmation by US mail. Please include a second self-addressed, stamped envelope with your entry if you are requesting a Judging Program and Schedule by US mail.**

**Postdated or returned checks do not constitute a valid entry fee.** LSDOC will add a collection fee of \$25 to the amount of each returned check.

**No refund for duplicate entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of entries.** No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance. LSDOC may decline any entry and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against LSDOC or any official thereof.

**Refunds.** Entry fees shall not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If it is impossible to open or to complete the trial because of riots, civil disturbances, or other acts beyond the control of the Trial Committee, refunds of entries will not be made. **Refunds of \$5 or less will not be made.**

**Errors on entry forms.** Owners are responsible for errors in the completion of entry forms. Corrections cannot be made after the closing date. Please be certain that you select the right trial(s), fill in the right class(es) and have the correct jump height on your entries. No entry fee will be refunded in the event of such errors or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to avoid errors.

**Bitches in season** are not permitted to compete or be on the trial grounds. If a female is withdrawn from competition because she came into season, the trial secretary must be notified in writing no later than one-half hour prior to the start of the first class in the trial. The club will refund the entry fee, less \$5.00 (per trial) processing fee upon written certification by a veterinarian given to the Trial Secretary before the start of judging each day.

**Exhibitors are responsible for the behavior of their dogs.** All dogs present must be confined to their crates except when being pottied, warmed up, or judged. Dogs being pottied or warmed up must be held on lead. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dog creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, refund of any entry fees will not be made.

**Handlers WITHOUT DOGS are welcome at ringside to watch Rally Trial judging if space permits.** The Rally Trial Committee Members will remind anyone at ringside with a dog that their dog must be crated while the handler is watching judging. The ring entrance and exit must be clear at all times. The Rally Trial Committee is committed to the safety of all dogs and handlers, and we thank you in advance for your support.

**Exhibitors and guests are responsible for the behavior of any child(ren) who accompanied them.** Any exhibitor or guest whose child or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made. The Club and the Trial Facility assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children.

**The Judge will not wait for any dog holding up a class.** Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Dogs may arrive one hour prior to their scheduled time of judging. Dogs not required for further judging may be excused.

**Pinch/prong and electrical collars** (dummy or not) are not allowed on trial grounds.

The Club and the Trial Secretary have no obligation or responsibility to provide a public address system or stewards to call or locate dogs that are not present at the ring when required. Exhibitors are responsible for being at the ring when it is their turn to run.

# AKC® Code of Sportsmanship and Civility

**Preface:** The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
