### WAIT LIST

The Trial Secretary will establish a wait list in order to fill openings created by entries that are withdrawn prior to **6:00 pm on the Sunday prior to the first day of the trial**. All entries must be received prior to the closing date and time. The full entry fee shall be refunded to an entrant whose entry is replaced by a wait-listed entry. **Conditional entries cannot be accepted, i.e., "If I can't get in for both trials on one day, I don't want to be in any trials."** Wait-listed entries will be filled in order of receipt on a per-run basis.

### TRIAL HOURS

7:00 am to 7:00 pm CST. The building opens for set-up at 7:00 a.m. on Saturday and Sunday. **Runs will start no earlier than 8:00 am.** Friday Set-Up Is Not Available.

### CRATING

- ★ Indoor crating is VERY limited. Workers get priority on indoor crating space.
- ★ LSDOC reserves the right to ask exhibitors to stack crates and limit chairs if the need for more space is required. Large lounge-type chairs are not allowed inside the building.
- ★ Mats are NOT allowed if you are crating inside. Chairs will be allowed only if space is available. Spectator chairs will be allowed ringside as long as they don't impede or interfere with foot traffic and space is available. LSDOC reserves the right to ask for chairs to be removed. Failure to comply can result in a committee hearing. **All chairs MUST have rubber caps on each leg to protect the mats or have a cardboard square (provided if needed) under each leg.**
- ★ Exercise pens are not permitted inside. All dogs who are not being warmed up, shown, or "pottied" must be securely crated.
- ★ Additional crating space is available under cover on dirt outside the door to the ring area. The outdoor crating area has a very large overhead fan (Big Ass Fan) and sunscreens for added comfort. Car crating is very convenient.

- ★ Any requests for transfers between trials must be received in writing no later than 30 minutes prior to the start of the next trial.

## Class Order

**Saturday Class** order will be **ascending** from lowest to highest jump height (small to tall) in classes in which jumps are used.

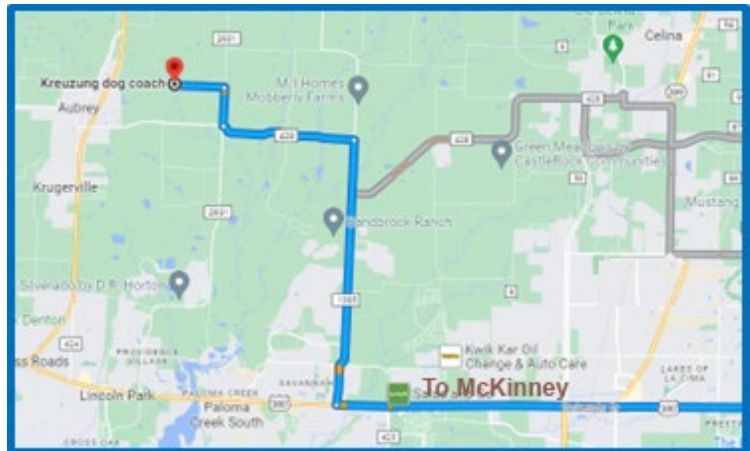
**Sunday Class** order will be **descending** from highest to lowest jump height (tall to small) in classes in which jumps are used.

Please ensure that you have included your dog's jump height on the entry form.

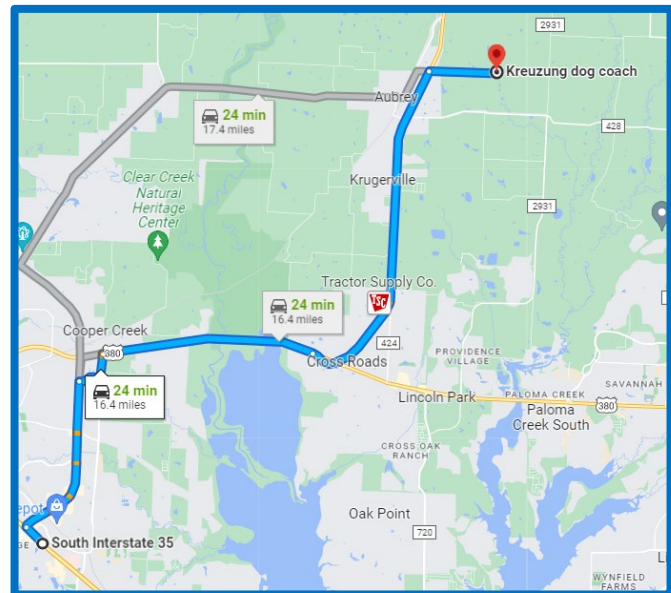
The order of the classes both days will be: Choice, Master, Excellent, Advanced, Intermediate, Novice for all 4 trials. A lunch break will be taken between the 2 trials each day.

## Directions to Trial Site

**From McKinney, TX - US 75 (Central Expressway) at Hwy. 380:** Travel west on Hwy, 380 (University Dr.) 15 miles to FM 1385. Turn right on FM 1385. Travel 5.3 miles to FM 428 W and turn left. Travel 2.7 miles to FM 2931/FM 2831 and turn right. Travel 1/8 of a mile to E Blackjack Rd E and turn left. Travel 1 mile. Kreuzung Dog Coach is on the right. **VERY IMPORTANT: Do NOT go over 5 mph down the driveway past the house. The training building is behind the house.**



**From Dallas –** Traveling North on I-35 toward Denton, exit on Loop 288 N. Travel 3.2 miles and turn right on Prominence Pkwy and travel 4/10 of a mile to N. Mayhill Rd and turn left. Travel 1/2 mile and turn right on US 377 E/University Drive. Travel 4 miles and take a slight right to US 377 N. Travel 5.5 miles and turn right on E. Blackjack Rd. E. Travel 1.3 miles. Kreuzung Dog Coach is on the left. **VERY IMPORTANT: Do NOT go over 5 mph down the driveway past the house. The training building is behind the house.**

## Notices to Exhibitors

**If a legible email address is provided, confirmations, the Judging Program and the Schedule will be emailed.** Paper copies will only be mailed at the request of the exhibitor. Should a confirmation not be received by the exhibitor within a reasonable time, please notify the Trial Secretary at 972-841-4066 or email [tralsecretary@ntxagility.com](mailto:tralsecretary@ntxagility.com). **Please include a self-addressed, stamped envelope with your entry if you are requesting a paper confirmation by US mail. Please include a second self-addressed, stamped envelope with your entry if you are requesting a Judging Program and Schedule by US mail.**

**Postdated or returned checks do not constitute a valid entry fee.** LSDOC will add a collection fee of \$25 to the amount of each returned check.

**No refund for duplicate entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of entries.** No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance. LSDOC may decline any entry and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against LSDOC or any official thereof.

**Refunds.** Entry fees shall not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If it is impossible to open or to complete the trial because of riots, civil disturbances, or other acts beyond the control of the Trial Committee, refunds of entries will not be made.

**Refunds of \$5 or less will not be made.**

**Errors on entry forms.** Owners are responsible for errors in the completion of entry forms. Corrections cannot be made after the closing date. Please be certain that you select the right trial(s), fill in the right class(es) and have the correct jump height on your entries. No entry fee will be refunded in the event of such errors or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to avoid errors.

**Bitches in season** are not permitted to compete or be on the trial grounds. If a female is withdrawn from competition because she came into season, the trial secretary must be notified in writing no later than one-half hour prior to the start of the first class in the trial. The club will refund the entry fee, less \$5.00 (per trial) processing fee upon written certification by a veterinarian given to the Trial Secretary before the start of judging each day.

**Exhibitors are responsible for the behavior of their dogs.** All dogs present must be confined to their crates except when being pottied, warmed up, or judged. Dogs being pottied or warmed up must be held on lead. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dog creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, refund of any entry fees will not be made.

**Handlers WITHOUT DOGS are welcome at ringside to watch Rally Trial judging.** The Rally Trial Committee Members will remind anyone at ringside with a dog that their dog must be crated while the handler is watching judging. The ring entrance and exit must be clear at all times. The Rally Trial Committee is committed to the safety of all dogs and handlers, and we thank you in advance for your support.

**Exhibitors and guests are responsible for the behavior of any child(ren) who accompanied them.** Any exhibitor or guest whose child or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made. The Club and the Trial Facility assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children.

**The Judge will not wait for any dog holding up a class.** Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Dogs may arrive one hour prior to their scheduled time of judging. Dogs not required for further judging may be excused.

**Pinch/prong and electrical collars** (dummy or not) are not allowed on trial grounds.

The Club and the Trial Secretary have no obligation or responsibility to provide a public address system or stewards to call or locate dogs that are not present at the ring when required. Exhibitors are responsible for being at the ring when it is their turn to run.
