### CHECK-IN & MEASUREMENTS



Exhibitors are required to have a valid Official Jump Height Card/ Valid yellow form for each of their dogs and must be able to present it at any time if requested

during the trial.

**An AKC rep is expected to be at the trial so there should be a Measuring Official present.** ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. Forms will be available at the ribbon-label table. Please fill out a form before requesting to be measured. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it. If your dog needs to be measured, it is your responsibility to have it done before you run. Failure to do so will result in removal of any qualifying runs you receive.

### Armbands Not Required

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the mandatory use of identifying stickers/armbands worn by agility exhibitors. The club is not requiring armband stickers.

Traditional check-in is not required. Please check in at the gate on the gate sheet prior to your class.

### CONCESSIONS NOT AVAILABLE

Concessions will **NOT** be available at the trial. Both fast food and restaurants are located within easy driving distance.

**Please feel free to bring your own snacks, drinks and lunch.**

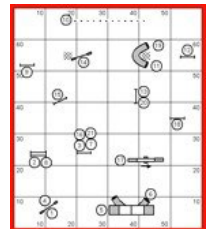
### MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the trial secretary via email **no later than 6:00 PM Monday, February 14.** **Day-to-Day Move-Ups are permitted** if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Friday for a Saturday move-up or on Saturday for a Sunday move-up.

There will be a photo area set up for exhibitors to take pictures. Please help yourself and your pups to the photo op.



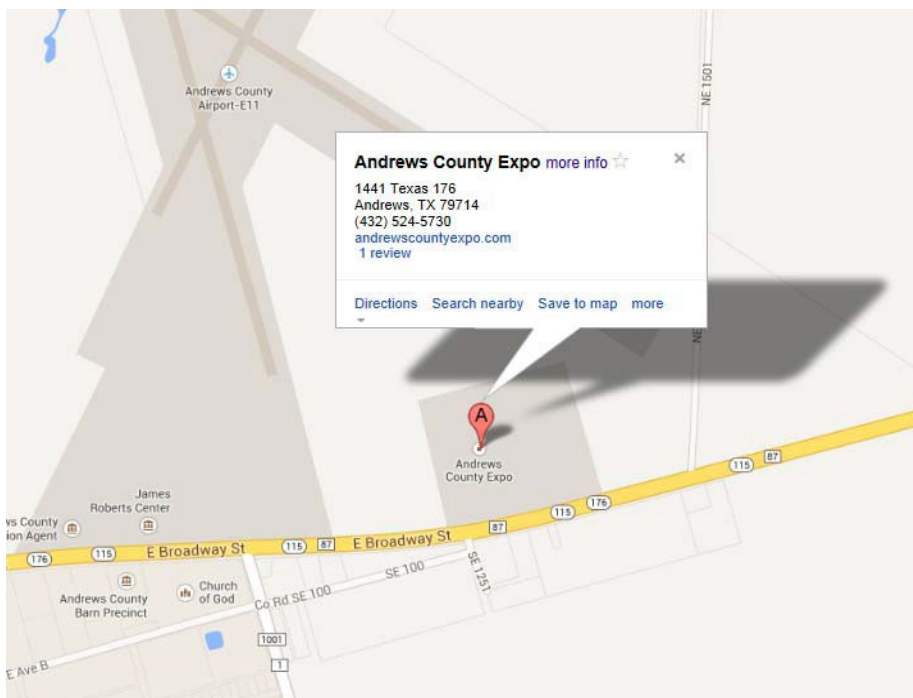

**From Odessa, TX.** from I-20 take St. Hwy 385 North. Approximately 34 miles to Andrews, TX. Hwy 385 becomes Main Str. through town. Turn East on Broadway (St. Hwy 176) and go approx. 3 miles. The ACE arena is on the North side of the road, next to the municipal airport.

**From Midland, TX.** from I-20 take FM 1788 North, past the Midland International Airport approx. 40 miles. Turn West on St. Hwy 176 and go approx. 7 miles. The ACE arena will be on the North side of the road.

**From Big Springs, TX.** from I-20, Exit St. Hwy 176 North, 63 Miles, to Andrews, TX. The ACE arena will be on the North side of the road.

**From Lubbock, TX.** take Hwy 385 South, to Andrews, TX. Hwy 385 will become Main St. through town. Turn East on Broadway (St. Hwy 176) and go approx. 3 miles. The ACE arena is on the North side of the road, next to the municipal airport.
