Measuring



All agility dogs are required to have an Official Jump Height Card. **The Judge, Mr. Liu, is a VMO (Measuring Official).**

ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. Forms will be available at the check-in table. Please fill out a form before requesting to be measured. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it. **If your dog needs to be measured, it is your responsibility to have it done before you run.**

Check-In

(Armbands Not Required)

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), DAWG will not be requiring the use of armband stickers, so traditional check-in is not required.

Be sure to check in on the Gate Sheet in your ring prior to running.

Arrival & Setup



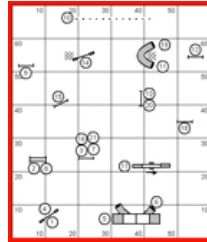
General set up is allowed each morning of the trial. The building opens at 6:30 a.m. all four days.

Running Orders and Course Maps

Each judge will supply course maps. **Please take ONE copy so we will have sufficient copies for every exhibitor.** Running orders will be posted in the spectator area on the south side of the rings and at the gate. 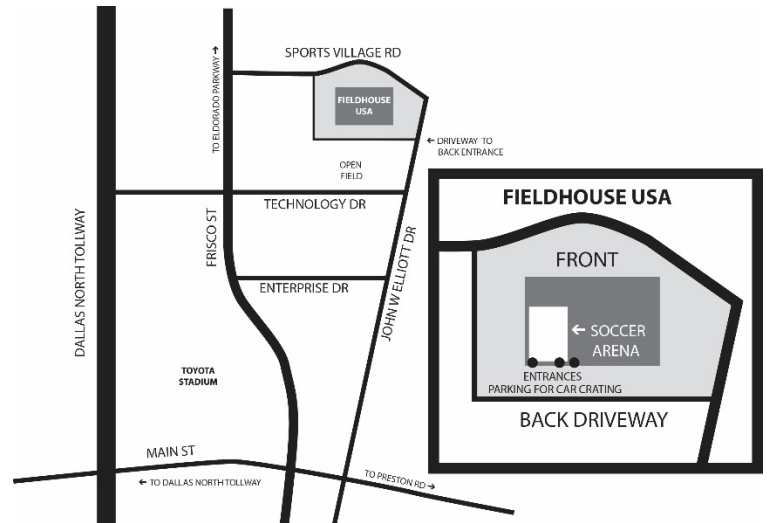

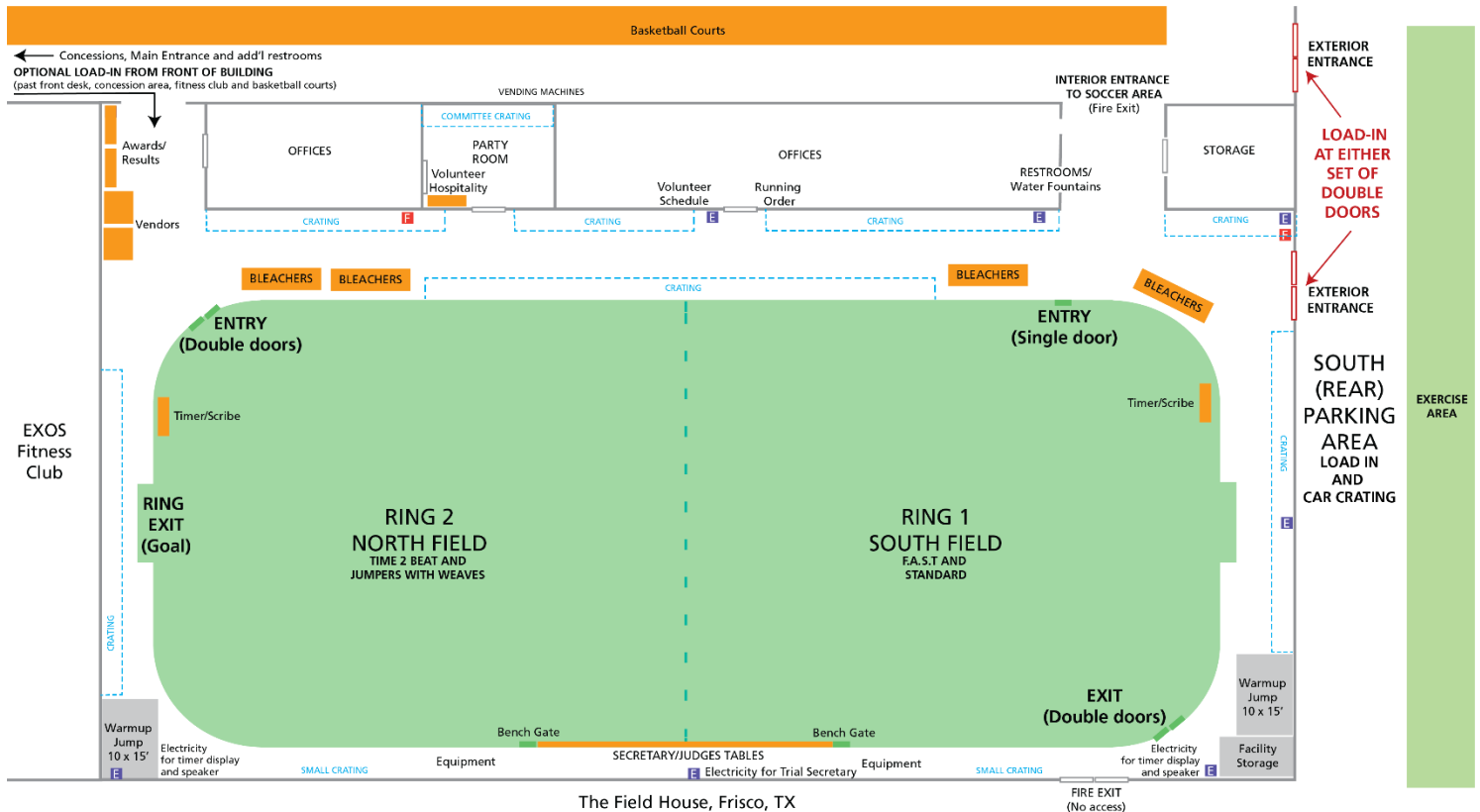
From Dallas North Tollway:

- Approximately 4.5 miles North of Hwy. 121, exit onto Main St/FM-720
- Turn Right onto Main Street
- Travel 0.53 miles and Turn left onto John W Elliott Dr. If you reach 1st St you've gone about 0.1 miles too far
- Travel .61 miles past an open field on your left.
- Turn left immediately into Fieldhouse USA's back driveway on the south side.
- **Entry doors and load-in are at the back (south) side of the building.**



IMPORTANT....

Crating space is limited. If you have multiple dogs, please bring wire crates to stack, if possible. No mats or oversized chairs, please. **An area will be marked for people who wish to crate out of their cars nearest the back load-in doors.** If you park there and are not car-crating, a very loud and obnoxious announcement will be made instructing you to move your vehicle. Don't be "that guy."
