Check-In and Measuring Info Armbands Not Required

Chapter 1, Section 19 of the Regulations for Agility Trials has been amended to eliminate the <u>mandatory</u> use of identifying stickers/armbands worn by agility exhibitors. DPOCM is not requiring armband stickers.

Traditional check-in is not required. Please check in at the gate on the gate sheet prior to your class.

MEASURING



Exhibitors are required to have a valid Official Jump Height Card/ Valid yellow form for each of their dogs and must be able to present

it at any time if requested during the trial.

Unless an AKC rep comes to the trial, there will be not be a Measuring Official at this trial. Measurements will not be official - it will only get you through the weekend. If you are entered in Novice or Open, you do not have to get there early to be measured. It will be open all day. Measurements can be done before Novice or Open.

If your dog needs to be measured, it is YOUR responsibility to have a measurement done prior to running and failure to do so will result in the cancellation of any qualifying scores.

CONCESSIONS NOT AVAILABLE

Concessions will **NOT** be available at the trial. Both fast food and restaurants are located within easy driving distance. Please feel free to bring your own snacks, drinks and lunch.

MOVE-UPS

Be sure to let the trial secretary know if you've earned a new title since you

entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the trial secretary via email no later than 6:00 PM Monday, September 3. Day-to-Day Move-Ups are permitted if you fill out a move-up form (available at the check-in table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Friday for a Saturday move-up or on Saturday for a Sunday move-up.

Exhibitors are allowed to set up beginning at 10:30 am on Thursday, at 7:30 am on Friday and Saturday, and at 7:00 am on Sunday.

MAP AND DIRECTIONS TO TRIAL SITE FROM I-20...


WESTBOUND: Take **Exit 135** (Cotton Flat Road). The Horseshoe will be on the right.
