CHECK-IN & MEASUREMENTS

All agility dogs are required to have an Official Jump Height Card and must be able to

present it if asked. Don't forget to bring your height card in case someone asks for it.

There will be no measuring of dogs unless an AKC rep happens to come to the trial (not expected).

ARMBAND STICKERS NOT REQUIRED

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), the club will not be requiring the use of armband stickers, so traditional check-in is not required.

No paper check-in will be required. <u>We</u> will be using the Agility Gate App for check-in on your phone.... See Page 2 for more information.



Concessions will be available. Both fast food and restaurants are located within easy driving distance.

No other food or drink is allowed at the show site. Your cooperation is greatly appreciated. Use of Coolers: The use of small coolers is permitted for dog treats and dog food ONLY.

DOGS MAY NOT BE LEFT IN THE BUILDING OVERNIGHT.



Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the

trial secretary via email no later than Monday, August 29, 2022 at 6:00 pm. Day-to-Day Move-Ups are permitted if you fill out a moveup form (available at the ribbon label table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Fri for a Sat move-up, on Sat. for a Sun. move-up or on Sun. for a Mon. moveup.

ARRIVAL & SETUP-IMPORTANT!

The building will be open for crating at 7:30 am on Friday, Sept. 2. Please do not come any earlier than 7:30 am on Friday. Any crates that are set up prior to that time will be removed. The building will also be open no later than 7:00 a.m. on Saturday, Sunday, and Monday of the trial.

Field 4 at the back of the facility will be used for additional crating. Mats and/or tarps <u>will be required</u> in that area.

CRATING SPACE WILL BE TIGHT. PLEASE BE COURTEOUS OF OTHER EXHIBITORS AND CONSERVE SPACE AS MUCH AS POSSIBLE. PLEASE NO LARGE LOUNGE CHAIRS. X-PENS ARE ALLOWED FOR 3 OR MORE DOGS ONLY. THE TRIAL COMMITTEE HAS THE RIGHT TO ASK YOU TO COMPACT YOUR CRATING SPACE. THANK YOU IN ADVANCE!

We will be utilizing the AGILITY GATE APP for the exhibitors' convenience.

Agility Gate is a free-to-download app that allows competitors to check-in their dogs via their mobile phone or tablet at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring.

Course maps will be posted on the Agility Gate App each night at midnight prior to each day of the trial.

BE SURE TO CHECK IN EACH MORNING FOR ALL YOUR CLASSES! IF YOU NEED TO BE MARKED ABSENT, YOU CAN DO THAT TOO - FROM HOME!!

IMPORTANT...

We still have a <u>wait list on Saturday and Sunday</u>. We hope everyone can be there, but if you need to pull, please let us know as soon as possible (before next Sunday, August 28 at 6:00 pm) so we can put others in. Also, if you've entered more runs than you really want to do, you can cancel a Saturday and/or Sunday run or two and that will allow others to get in as well. Of course, we will refund your entry fees for any runs you pull if we still have runs on the wait list. You can pull entries <u>for Saturday and Sunday only</u> until NEXT Sunday, August 28 at 6:00 pm <u>IF</u> we can replace your runs with wait-listed entries. You will get a full refund for any runs you pull <u>IF</u> we can replace you with a wait-listed entry. If we run out of wait list, we won't be able to pull you and refund your entry fees.



Exhibitors are expected to maintain hotel premises and their dogs in a quiet, clean and well-kept manner and for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities.

Complaints lodged against any exhibitor will be under the auspices of our Trial Committee and reported to the AKC. This is an AKC-supported measure.

THE TRIAL SITE

As anyone who has trialed at Soccer City OKC knows, this is a fabulous facility and the management is happy to have us back because we are all courteous with parking and picking up after our dogs. Please help us keep this venue for agility trials by following a few simple rules!

Parking – Parking is limited at this trial site. <u>We ask that you do not bring RVs to the trial site or any vehicle that takes</u> <u>up more than one parking spot</u>. Reservations for parking for a <u>limited number</u> of <u>CLASS C OR SMALLER</u> RV's is available. To be able to park your RV at Soccer City during the trial (<u>day only</u>), see the RV information on the Hotel Page of this Judging Program. Overnight parking will not be permitted. A list of RV parks has been provided at the end of this Judging Program. Please tow a car or hitch a ride with a friend. This is very important. - * Field 4 at the back of the facility will be used for additional crating. Mats and/or tarps will be required in that area. Mats and large lounge-type chairs cannot be used in the main area. Xpens are allowed for 3 or more dogs only. The trial committee might ask you to condense your space if necessary. Please be courteous regarding this.... Everyone needs crating space.
- * No dogs on the balcony.
- * No food or open containers on the turf.
- * Keep treats in a container on the turf.
- * No grooming inside the building.
- * No parking on the street in the subdivision (they'll have you towed!!)
- * Be respectful of the neighborhood surrounding the venue.
- * Keep your dogs on leash and as always ensure that you clean up after them.
- * There are walking trails nearby so please minimize exercising dogs in the subdivision.
- * PLEASE KEEP ALL OUTSIDE DOORS CLOSED. If you come in or go out, please be sure to close the door behind you! This has been a problem in the past and we need to be sure to keep it from happening. We need the cold air to stay inside, please!

PLEASE DO NOT PARK ON THE STREET – YOU WILL BE TOWED.

From OK-74 (Lake Hefner Parkway), take the Hefner Road exit and turn West towards the lake. Go about 2 miles, and turn right at Meridian Ave (at the stoplight). Go about .5 miles to Old Farm Rd. Turn left onto Old Farm Rd. Soccer City will be immediately on your left at 4520 Old Farm Road.


