# CHECK-IN & MEASUREMENTS

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked.

Don't forget to bring your height card in case someone asks for it.

Our Judge, Lisa Selthofer is a Measuring Official (VMO). ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. Forms will be available at the ribbon-label table. Please fill out a form before requesting to be measured. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it. If your dog needs to be measured, it is your responsibility to have it done before you run. Failure to do so will result in removal of any qualifying runs you receive.

#### ARMBAND STICKERS NOT REQUIRED

No paper check-in will be required. <u>We</u> will be using the Agility Gate App for check-in on your phone.... See Page 2 for more information.

**MOVE-UPS** Be sure to let the trial secretary know if you've earned a new title since you entered the trial so your dog can be moved up! Pre-trial move-ups must be submitted to the bill no later than Monday

trial secretary via email **no later than Monday**, **August 28, 2023 at 6:00 pm. Day-to-Day Move-Ups are permitted** if you fill out a moveup form (available at the ribbon label table) and give it to the trial secretary at any time, but no later than 20 minutes after the last dog crosses the finish line on Fri for a Sat move-up, on Sat. for a Sun. move-up or on Sun. for a Mon. moveup.

### **ARRIVAL & SETUP-IMPORTANT!**

The building will be open for crating at 8:30 am on Friday, Sept. 1. Please do not come any earlier than 8:30 am to set up. RDAC Members will be moving equipment in and setting up the rings. The building will also be open no later than 7:00 a.m. on Saturday, Sunday, and Monday of the trial.


Field 4 at the back of the facility will be used for additional crating. Mats and/or tarps <u>will be required</u> in that area.

A preliminary running order will be posted on the <u>www.ntxagility.com</u> website on or before Wednesday prior to the first day of the trial. <u>Please check in using Agility Gate – even</u> from home. If you will be absent, please mark "scratch" for your dog on agility gate.

# We will be utilizing the AGILITY GATE APP for the exhibitors' convenience.

Agility Gate is a free-to-download app that allows competitors to check-in their dogs via their mobile phone or tablet at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring.





### TO VETERINARIAN FROM SHOW SITE

Approximate Travel Time: 16 Minutes

Turn right out of the Soccer City parking lot and left onto Old Farm Rd toward N Meridian Ave. Go 0.04 miles and turn **left** onto N Meridian Ave. Go 0.17 miles and take the 1<sup>st</sup> **left** onto NW 122nd St. Go 0.85 miles and turn **left** onto N Macarthur Blvd. Go 6.75 miles... 2700 N MacArthur Blvd is on the **left**.



Exhibitors are expected to maintain hotel premises and their dogs in a quiet, clean and well-kept manner and for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damages to motels/hotels or the event site and may result in disciplinary action by the Trial Committee. Entries may be refused in the future for previous misuse of the motel facilities.

Complaints lodged against any exhibitor will be under the auspices of our Trial Committee and reported to the AKC. This is an AKC-supported measure.

# THE TRIAL SITE

As anyone who has trialed at Soccer City OKC knows, this is a fabulous facility and the management is happy to have us back because we are all courteous with parking and picking up after our dogs. Please help us keep this venue for agility trials by following a few simple rules!


**Parking** – Parking is limited at this trial site. <u>We ask that you do not bring RVs to the trial site or any vehicle that takes</u> <u>up more than one parking spot</u>. Reservations for parking for a <u>limited number</u> of <u>CLASS C OR SMALLER</u> RV's is available. To be able to park your RV at Soccer City during the trial (<u>day only</u>), see the RV information on the Hotel Page of this Judging Program. Overnight parking will not be permitted. A list of RV parks has been provided at the end of this Judging Program. Please tow a car or hitch a ride with a friend. This is very important. PLEASE SEE THE RV INFORMATION PAGE AT THE END OF THIS JUDGING PROGRAM.

- \* Crating will be tight, so please be courteous. <u>Field 4 at the back of the facility will be used for additional</u> <u>crating. Mats and/or tarps will be required in that area.</u> Mats and large lounge-type chairs cannot be used in the main area. Xpens are allowed for 3 or more dogs only. The trial committee might ask you to condense your space if necessary. Please be courteous regarding this.... Everyone needs crating space.
- \* No dogs on the balcony.
- \* No food or open containers on the turf.
- \* Keep treats in a container on the turf.
- \* No grooming inside the building.
- \* No parking on the street in the subdivision (they'll have you towed!!)
- \* Be respectful of the neighborhood surrounding the venue.
- \* Keep your dogs on leash and as always ensure that you clean up after them.
- \* There are walking trails nearby so please minimize exercising dogs in the subdivision.
- \* PLEASE KEEP ALL OUTSIDE DOORS CLOSED. If you come in or go out, please be sure to close the door behind you! This has been a problem in the past and we need to be sure to keep it from happening. We need the cold air to stay inside, please!

# PLEASE DO NOT PARK ON THE STREET – YOU WILL BE TOWED.

This venue is in the middle of the Summerfield subdivision. Your GPS should be able to find the address correctly. From OK-74 (Lake Hefner Parkway), take the Hefner Road exit and turn West towards the lake. Go about 2 miles, and turn right at Meridian Ave (at the stoplight). Go about .5 miles to Old Farm Rd. Turn left onto Old Farm Rd. Soccer City will be immediately on your left at 4520 Old Farm Road.
